Students are admitted to various programmes through a single window system for admission – Centralized Admission Process under Calicut University (CAP). Diversity of students is ensured as per the Government/University regulations. The college assesses the knowledge, skills and needs of the students before the commencement of the programmes. Bridge courses, Remedial Teaching, and Enrichment programmes are offered. Predominantly Lecture Method in an interactive manner is followed. Teachers also adopt Projects, Field trips and Computer assisted teaching. Teachers are fully qualified. 54 teachers have Ph.D. 2 teachers are appointed as Emeritus Professors by UGC.

Continuous Evaluation of students is achieved through class tests, Seminars and Assignments. Marks are communicated to the parents in class wise parent teacher meeting.

Several Government support schemes are available for students: Walk With a Scholar(WWS), Scholar Support Programme (SSP), Additional Skills Acquisition Programme (ASAP), ASPIRE fellowship for Hindi and Sanskrit.

Students' performance in examinations is good. College produces toppers in university examinations at UG and PG level.

Fifteen Minor and Two major Projects funded by UGC, DST and other research organizations have been completed. FIST funding for Science department to the tune of 90 lakhs has been received.

Five teachers are offering consultancy services to other academic institutes.

Teachers are invited as resource persons to different colleges and universities.

Few teachers are members of academic bodies and syndicate in Calicut University.

Three teachers have received UGC Raman Fellowship and One teacher has received Fulbright Fellowship. 390 plus research papers are published and presented.

The National Selection Committee has recommended the college for hosting a Fulbright Specialist.

Two neighboring villages are adopted. *Pothichoru* is a programme followed by students to collect and distribute food packets to the needy. *Vayomithran* is a programme under which the students provide moral and emotional support to elders on regular basis. A free psychological counseling is available to the students once a week. Several teachers are involved in different levels of community development activities like deaddiction of alcoholics, manages Centre for Mentally Handicapped adults and Literacy programmes in villages voluntarily

The college has adequate space for academics, co-curricular and extracurricular activities. There are sixty classrooms, five laboratories, two Auditoriums, five Seminar Halls, Open Stage, Playground, Gymnasium and Rifle Shooting Range.

The college has a fully computerized Library with open rack system. The library has more than 78000 books, 95 Journals, 24 Periodicals and Palm Leaf Manuscripts. A separate section with Braille books and audio aids are also maintained for differentially abled students. Facilities like ramps and wheel chairs are also present.110 computers and Internet facilities are available at departments.

There are 2 Hostels – One for girls (intake capacity: 210) and other for boys (intake capacity:135).

The college has substantial number of economically and socially backward section of students. More than 80% of students avail freeships and scholarships. In addition to government scholarships and freeships, the college gives endowments worth Rs. 1.5 lakhs to needy, deserving students. Approximately 100 students get placement in the off campus interviews. More than 35% students pursue higher education and 220 students

have cleared NET / SLET Exam. 16 students have completed PhD from Malayalam Department.

College has 2 units of NSS. 2 Units of NCC, 1unit of boys and 1 unit of girls. NCC students are selected for participation in the Republic Day Parade.

College regularly conducts sports and cultural events at intra and inter-collegiate level. Seven International and 13 National players are produced. One player from the college has won gold medal at the international level of weightlifting

A College Council assists the Principal on the internal affairs of the college. Teachers and students are involved in various decision making committees like

Purchase, College Development, Canteen, Admission, Examinations etc.

There is a retiring room for girls and two sanitary napkin vending machines.

College has a green campus. The college has preserved 18-acres green zone named as "Ooty" in the campus.

Solid waste management is carried out systematically, Sanitary napkins and other non – biodegradable waste are incinerated using the incinerators installed on the campus.

Bio – degradable waste is taken to landfills and allowed to degrade naturally.

College practices two ways of harvesting rainwater.

- 1. Surface run off harvesting
- 2. Roof top rainwater harvesting

This college is the first in Kerala to open HEPSN.

Since 2013, the college has a fully functional HEPSN (Higher Education for persons with special needs) in a separate building with assistive technology.
